3. Hazards Identification

This product is not classified as dangerous according to the Chemicals [Hazard Information and Packaging] Regulations [Also refer to section 11]

4. First Aid Measures

General: In all cases of doubt, or when symptoms persist, seek medical attention. Never give anything by mouth to an unconscious person.

5. Fire Fighting Measures

Extinguishing media:

This product is not flammable. Use fire extinguishing media appropriate for surrounding materials.

6. Accidental Release Measures

Stop leak if possible without risk. Absorb in vermiculite, dry sand or earth and place into containers. Flush with plenty of water to clean spillage area. Do not contaminate water sources or sewer.

7. Handling and Storage

Handling

Avoid spilling, skin & eye contact.

Storage

Observe the label precautions. Store between 5 and 25°C in a dry well ventilated place, away from sources of heat, ignition and direct sunlight. Prevent unauthorised access. Opened containers should be carefully resealed and stored upright to prevent leakage.

8. Exposure Controls/Personal Protection

Engineering Measures

Provide adequate ventilation. Where reasonably practicable this should be achieved by the use of local exhaust ventilation and good general extraction. If these are not sufficient to maintain concentrations of particulate and/or solvent vapours below the relevant occupational exposure limits, suitable respiratory protection equipment should be worn. 9. Stability and Reactivity

Stable under the recommended storage and handling conditions (See Section 7).

In a fire, hazardous decomposition products such as smoke, carbon monoxide, carbon dioxide and oxides of nitrogen may be produced. Keep away from oxidising agents and strongly alkaline / acidic materials to prevent the possibility of exothermic reaction. Keep dirty wipers in a closed container.

10. Toxicological Information

There is no data available on the product itself. It is formulated within the SPBIM guidelines on materials for exclusion from printing inks and varnishes. Exposure to organic solvent vapours may result in adverse health effects such as irritation of the mucous membrane and the respiratory system and adverse effects on the renal and central nervous systems. Symptoms include, headaches, dizziness, fatigue, muscular weakness, drowsiness and in extreme cases, loss of consciousness. Repeated or prolonged contact with the product may lead to removal of natural fats from the skin resulting in non-allergic contact dermatitis and absorption through the skin. Splashes in the eyes may cause irritation and irreversible local damage.

11. Ecological Information

There is no data available on the product itself. The product should not be allowed to enter drains or to be deposited where it can affect ground or surface waters. The Air Pollution Control requirements of regulations made under the Environmental Protection Act may apply to the use of this product.

12. Disposal Considerations

Do not allow into drains or watercourse or dispose of where ground surface waters may be affected.
